<u>Treasurer's Report from December 2022 to February 2023</u>

Treasurer Leesa McClelland performed several audits with 3 auditors; Former IAD treasurer; Lisa Chamberlin, Onye Davis, and Michael Reineck at the IAD office. Tavis Koopman was also present for one auditing meeting. Secretary Lisa Wilson and Member at Large Gary Olsen were present for the auditing process, too. We all agreed that Former President Beth Yaste will have to pay back for unauthorized access to the bank.

In December 2022, President Beatrice Pfaff found a Fidelity Bond that brings to our attention. Our board of members agreed to pay \$222.00 dollars per year.

In December 2022, We spent \$3,650.00 dollars. Treasurer Leesa McClelland paid 60 dollars per person for Members at Large; Armani Aluta and Gary Olsen for diem at NAD conference. Ze also paid Vice President Candice Lisenby for her past invoices with mailiter fees. Ze also paid several interpreting agencies related to Deafblind funds. Quickbooks fees were paid, too. We also paid for bills related to quickbooks and credit cards that totals to \$254.00 dollars. We received \$385.00 dollars on December 30, 2022. In addition, Ze also finally deposited \$385.00 dollars from PTCO sales (15 t-shirts were sold).

In January 2023, We received \$10,723.81 dollars. InTrac granted \$8,000 for Deaf Youth related. Several organizations donated petty cash to IAD. Sorenson donated \$250.00 dollars for DeafBlind Funds. We paid \$1,363.00 dollars for our marvelous bookkeeper; Lad Baird Accounting, Inc. and a credit card payment totals to \$363.00 dollars. We also had a situation where the ICRID check was returned due to no treasurer being on the board. This situation has been handled by President Bea Pfaff with their ICRID members.

In February 2023, We received \$2,080.00 dollars from DHHS for DeafBlind CoNavigator Training donation and a deposit slip totalling \$1,000 dollars from

ICRID with appropriate signatures. We also spent \$15,314.42 to Sharp Eyed Group, INC. for DeafBlind with a MOU. We also paid the bills for quickbooks and a credit card for mailiter fee (related to subscription for IDN-500).
